NOTICE OF INVITATION FOR BID

1. The Government of Nepal (GoN) has allocated funds towards the cost of supreme court and intends to apply part of the funds to cover eligible payments under the Contracts as specified in the table below. Bidding is open to all eligible Nepalese Bidders.
2. District Court Mugu, invites sealed bids or electronic bids from eligible bidders for the works that includes construction of Building and sentry post Building structure as specified in the table below. Bidders who do not meet the minimum qualifying criteria shall not be considered for contract award.

3. Bidders may submit their completed bids either electronically or as a complete hard copy. In case of e-submission, the applicant is required to deposit non refundable fee of NRs. 3000/- for each bid in the following account and the scanned copy (pdf file) of voucher/receipt of such deposition must be attached with the e-submission.

5. Last date of submission of completed documents is by 12:00 hrs (Noon) on the 12-07-2017. The bidder shall seal the Bidding Documents in a single envelope, addressing the Office Chief, District Court, Mugu and submit within time mentioned above at the District Court, Mugu. The submitted Bids will be opened at 13:00 hours at the same office on the same day in the presence of the contractor's representatives who choose to attend. Bidders, who choose to submit their bids electronically through e-procurement section of PPMO's website www.bolpatra.gov.np may download the necessary parts of the each bidding documents, prepare their Bids and submit their electronic Bids as specified in the Instruction to Bidders.
6. The Bid validity period for all the bids is 90 days from the last date of submission of the Bid.
7. Each Bid must be accompanied with bid security amount stated in the table below "The Work" deposited in the form of cash voucher in the above account or in the form of Bank Guarantee issued by a Commercial Bank (Class A) in Nepal, drawn in favor of District Court, Mugu as mentioned in the Bid Document having validity period not less than 120 days from the last date of submission of the Bid. In case of e-submission the scanned copy of voucher/receipt/guarantee of such deposition/Bank Guarantee must be attached with the e-submission.
8. Pre-bid meeting for all the bids shall be held on date 07-07-2017 at 13:00 hrs at District Court, Mugu.
9. Bidders are advised to visit the related field and assess the actual site conditions before submitting their bids.
10. The Employer reserves the right to accept or reject, wholly or partly, any or all the bids without assigning reason, whatsoever.
11. Bidders may withdraw or modify the bids 24 hours before last date of submission of bid by submitting of sealed application to the District Court, Mugu.
12. In case of electronically submitted PDF files, the bidder shall submit original bid security /documents and clarification within 7 days from the last date of bid submission. Bidders not submitting the above mentioned letters and documents within the specified time shall be considered non-responsive.
13. The Condition, Process and Procedures not mentioned above will be as per GoN public procurement act-2063 and public procurement Regulation-2064.
